

PACES is a 40-month (2023-2026) project funded by Horizon Europe that aims to encourage migration policymakers to adopt evidence from migration research as the basis for migration policymaking. The project seeks to improve our understanding of migration and migration policies by studying how people make decisions to migrate or to stay and how migration policies account for such migration decision-making processes.

### **Research questions**

- How do changes in society, individual life experiences and migration policy shape decisions to stay or to migrate over time and across space (across countries and along migration journeys)?
- How can this knowledge inform future migration policies and governance?

### Research design

To achieve its objectives, PACES conducts research in several EU Member States and a diverse group of African countries. The research is divided in two main components: migration policy decision-making and migration decision-making.
