Reproductive Violence in International Criminal Law Conference

Background: Violations of reproductive autonomy and reproductive health are quickly garnering increased attention in international criminal law (ICL), including in appellate jurisprudence of the International Criminal Court (ICC), and proceedings at the International Court of Justice (ICJ), but also scholarship. Reflecting this shift, the ICC Office of the Prosecutor's (OTP's) 2023 *Policy on Gender Crimes* consistently refers to 'reproductive violence' – a concept that was absent from the OTP's previous 2014 *Policy Paper on Sexual and Gender-Based Crimes*.

Recent years have also seen advances in the recognition of reproductive violence in domestic proceedings for war crimes, crimes against humanity and genocide (including both local universal jurisdiction cases), and a push by several states to increase protections for forced pregnancy and other forms of reproductive justice in the United Nations' Sixth Committee deliberations on a possible Convention on the Prevention and Prosecution of Crimes Against Humanity.

In this context, an expert forum on strategies to effectively understand, investigate and prosecute reproductive violence is a timely initiative.

This world-first international conference on reproductive violence in ICL will convene legal practitioners, scholars, activists, and survivors to engage in a comprehensive exploration of reproductive violence and its adjudication within the existing ICL framework and explore the need for potential legal reform.

The one-day hybrid format (simultaneous online and in-person participation) will enable participation of a diverse range of experts from The Hague and beyond.

Objectives:

- Highlight the full spectrum of reproductive violence, encouraging a holistic understanding that bridges explicitly recognized crimes and those prosecuted under broader ICL categories;
- Promote interdisciplinary dialogue between legal professionals, academics, activists, and survivors to integrate diverse insights and perspectives on reproductive violence;
- Facilitate opportunities for attendees to meet key players on addressing reproductive violence, promote ongoing dialogue and post-conference collaboration;
- Explore innovative strategies and legal tools to strengthen justice and accountability for reproductive violence survivors; and
- Discuss potential enhancements to the ICL framework to more comprehensively address reproductive violence.

Target audience:

- Practitioners in national and international prosecutions for war crimes, crimes against humanity, genocide and aggression (investigators, prosecutors, victims' legal representatives, judges, interpreters);
- Academics in international criminal law;
- Survivors and support organizations;
- International lawyers working as government legal advisors;
- NGOs, human rights defenders, and other activists working towards justice for war crimes, crimes against humanity, genocide and aggression; and

- A summary report outlining key discussion points and guidance raised by participants throughout the conference;
- An open-access compilation of all resources shared by speakers and participants; and
- A symposium of blog posts by panel moderators or speakers on selected subtopics.

As a prelude to the conference, a teach-in webinar on reproductive justice will be held on **10 June 2024** at **15:00-16:45 CET**.

This webinar aims to provide participants with an introduction to reproductive justice, its principles, history, and implications in the wider struggle for liberation – with particular attention paid to the role of reproductive justice in international law. We will explore how the visions and praxis of reproductive justice to expand our understanding of the limitations and possibilities of (international criminal) law as a tool towards liberation.
