# "Rethinking the regulation of agricultural markets for the agroecological transition in Europe"

#### **Foreword**

"This conference is a very important event for the European peasant movement. For the first time, farmers from all over Europe will reflect with researchers on the public policies necessary to ensure fair prices and decent incomes for those who produce food. The challenges are immense: the climate crisis, the rise in social inequalities, the erosion of biodiversity, food insecurity, geopolitical tensions, the disproportionate power of multinational companies, the aging of the agricultural population, the explosion of diseases linked to unhealthy diets, etc. It is urgent to think about innovative and bold political proposals, outside the box. By bringing together farmers, academics, civil society actors, political decision-makers, all on an equal footing, we give ourselves the means to participate in social change towards social and environmental justice."

#### **Objectives and approach**

What lessons can be drawn from the successes and failures of past policies to regulate agricultural markets, in Europe and elsewhere in the world, so as to rebuild the Common Agricultural Policy (CAP) in view of food sovereignty<sup>1</sup> and agroecological transition<sup>2</sup>?

Given the state and challenges of today's agriculture, in the European Union and elsewhere in the world, how can the CAP expand market regulation, including price support for farmers?

This International Conference of Researchers and Farmers aims to enable the exchange and the construction of new knowledges on this topic during the conference, and the writing of policy documents after the conference, so as to participate in the policy discussions regarding the CAP for 2027-2034. These discussions are due to start in spring 2025.

This conference brings together academics and peasants, small-, and medium-sized farmers from several European countries and beyond, as well some other players working on agricultural policies. More than 100 participants submitted contributions relating to the conference, which will be presented and discussed in plenaries and workshop sessions. Opening this space will facilitate knowledge exchange and knowledge building between farmers and academics - who each make up around 50% of the attendees – along with other invited actors.
